4. Term and Termination

- **Term:** This Agreement shall commence on the Effective Date with no end date unless provided in writing by GZCC Services Senior Executive to the participant.
- **Survival:** Notwithstanding termination, the Recipient's obligations with respect to the Confidential Information disclosed during the term of this Agreement shall survive indefinitely.
- Due to the sensitivity of the material the user agrees not to store Therapeutic Loop [™] material in a company data base unless the participant is the owner of such company.

5. Exclusions from Confidential Information

Confidential Information does not include information that:

- (a) Is or becomes publicly known through no breach of this Agreement by the Recipient.
- (b) Is received from a third party without breach of any obligation of confidentiality.
- (c) Is independently developed by the Recipient without reference to or reliance upon the Confidential Information with proven file date of conception.

6. Remedies

The Recipient acknowledges that any breach of this Agreement may cause irreparable harm to Therapeutic Loop TM. Accordingly, Therapeutic Loop TM shall be entitled to seek injunctive relief, in addition to any other legal or equitable remedies, for any breach or threatened breach of this Agreement at the cost of the participant.

7. No Warranty

All Confidential Information is provided "as is." Therapeutic Loop TM makes no warranties, express or implied, regarding the accuracy, completeness, or fitness for a particular purpose of any Confidential Information.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of **British** Columbia, Canada without regard to its conflicts of law principles.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous understandings, agreements, or representations, whether oral or written.

10. Amendments

Any amendment or modification of this Agreement must be in writing and executed by authorized representatives of both parties.

11. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions will continue in full force and effect.
